PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND STATEMENT  
MODIFICATION ORDER 2021**

The above order made on the 24 February 2021 under Section 119 of the Highways Act 1980 will divert that part of public footpath Colne Valley 198 having a width of 1.2 metres and shown on the plan annexed hereto by a bold solid line commencing at its junction with Manchester Road at point A at grid reference 0294 1158 and proceeding in a north easterly direction for 68 metres to point B at grid reference 0299 1163 to a new line for public footpath Colne Valley 198 having a width of 2 metres shown on the plan annexed hereto by a bold dashed line commencing at its junction with Manchester Road at point C at grid reference 0294 1161 and proceeding in a north easterly direction via point E for 58 metres to point D at grid reference 0299 1164.

Currently the Council buildings are closed to the public. Once Covid-19 restrictions are lifted documents will become available for viewing by appointment at Kirklees Council Customer Services Centre, Civic Centre 3, Huddersfield (Monday to Friday 0900-1700 except Thursday 1000-1700) and Legal Services, 2nd Floor, High Street Buildings, High Street, Huddersfield, HD1 2ND. Copies of the order and order plan may be obtained free of charge whilst copies last and then at standard office copying rates.

If the order is sent to the Secretary of State for the Environment for confirmation any representations or objections which have not been withdrawn will be sent with this order.
