Path Diversion application- Explanatory Statement

Under the Town & Country Planning Act 1990, local authorities have the power to make orders to stop up or divert public rights of way if they are satisfied that it is necessary to so in order to enable development.

An application has been received to stop up routes at Kenmore Drive, Kenmore View, Milton Terrace and Rooks Avenue, Cleckheaton. The application is made on the grounds that it would be required to implement planning application 2020/91746 for erection of extra care development providing 80 apartments

The Council is in receipt of a Definitive Map Modification Order Application (DMMO) to record footpaths on the area of land shown on the plan. No investigation or decision on the DMMO has taken place. Alternative public footpaths would be included in the order and provided in line with the development proposals. The applicant is also proposing to stop up tread lines or other lines of use across the site. The order would stop up any public rights over the claimed routes and the tread line routes and create new public footpaths over the alternative routes.

The routes to be stopped up commence at their junctions with Kenmore Drive, Kenmore View, Rooks Avenue and Milton Terrace and are shown by the bold solid lines, whilst the footpaths to be created are shown by the bold dashed line.

Any proposed stopping up order would come into effect only after it has been confirmed: this is a preliminary consultation process and simply provides an opportunity for views to be expressed.
