Note for the Local Plan Inspector on preparation of the Kirklees Economic Strategy

1.0 Background

- 1.1 The Kirklees Economic Strategy (KES) was prepared in early 2014 to cover the years 2014-2020.
- 1.2 The KES was developed with wide ranging input from within the Council and key external partners.
- 1.3 Cabinet on June 17th agreed to endorse the draft KES and agreed to a six week period of consultation on the draft. Policy Committee on 25 June debated the key points of the draft KES.
- 1.4 It was proposed that response to the consultation and a proposed Implementation Plan would be submitted to Cabinet for consideration in the autumn.
- 1.5 The KES was endorsed at Council on 16/7/2014 along with the Councils Joint Health and Wellbeing Strategy. The decision was as follows:

"That the Joint Health and Wellbeing Strategy, and the Kirklees Economic Strategy be endorsed and that the co-ordinated approach of 'Your Health, Your Economy' be approved."

- 1.7 This demonstrates that the KES was endorsed and approved as a joint strategic document in tandem with the JHWS at the Council meeting on 16/7/14.

2.0 Economic Resilience and Local Plan

- 2.1 Whilst the consultation period was open very few comments were received on the KES. Comments were invited by email.
- 2.2 As a consequence it was considered that no changes to the document should be made and the focus should be on the implementation of the KES.
- 2.3 Implementation of the KES was subsumed within the Council's approach to Economic Resilience and establishing greater certainty over what the Council would be able to resource in the light of reductions in overall budgets.
- 2.4 The focus has therefore been on making progress to deliver the KES and it is a clear underpinning principle of both ER and the Local Plan process.
- 2.5 The approach to Economic Resilience has been reported to Council including:

- 2.6 Since Cabinet endorsed the KES work has also progressed on the Local Plan and consultation on the Local Plan has continued over the period since July 2014.
- 2.7 The Local Plan has embedded economic assumptions from the KES and these have been subjected to the local plan consultation process and the KES has been commented on through the Local Plan process.
- 2.8 Furthermore, the Leeds City Region (LCR) Strategic Economic Plan (SEP) (CR9) provides the overarching economic objectives for the city region, of which Kirklees is a part. The First LCR SEP was completed in March 2014 with agreement reached by the LEP Board in July 2015 to undertake a light touch refresh. This involved an extensive programme of consultation and engagement which fed into the final document produced in May 2016. The identified priorities within the LCR SEP for Kirklees include regenerating Huddersfield and North Kirklees and providing space for businesses to grow which places an emphasis on engineering and manufacturing (CR9, page 32). The council's KES which was consulted on between 1st July 2014 and 12 August 2014 was used to inform this document.

11. Key Discussion; Kirklees Joint Health and Wellbeing Strategy and Kirklees Economic Strategy

To consider the following Motion submitted in the names of Councillors Turner, Marchington, A Pinnock, K Pinnock, Iredale, P Scott, Lawson, Burke, Ridgway, Blanchard and Wilkinson.

'That this Council:

(1) Notes that:

- there are 6580 people on the housing list who presently face a very long wait for a council owned home to become available;
- that there are not enough council owned homes of the right size available to tenants;
- the cost of rent in the private sector is higher and costs more in terms of housing benefit payments.
- (2) Recognises that there is real need to build homes in Kirklees that meet the needs of our communities.
- (3) Also notes potential benefits from building homes in appropriate locations including new homes bonus payments and reduced benefit costs.
- (4) Therefore resolves to:
- a) recommend to Cabinet that it makes every effort to tackle the shortage of housing in Kirklees by:
- i) using money collected from rents in the Housing Revenue Account to support the funding, with third parties, of the construction of housing in Kirklees;
- ii) using Right to Buy Receipts to part fund with third parties the repurchase of former Right to Buy Properties;
- iii) making full use of Government polices such as the New Homes Bonus; the empty clusters fund; the a new 'affordable rent' model; Tax Increment Financing and the Community Infrastructure Levy to attract investment and/or build housing.
- b) instruct the Chief Executive to write to Government on its behalf requesting that:
- i) councils be allowed to access the unused borrowing limits of other authorities so that new homes can be built;
- ii) the cap on borrowing which accompanied reforms of the HRA be removed so that councils can borrow against future revenue income potentially releasing some £50bn investment in affordable housing over time;
- iii) the Bank of England extend the scope of the Quantitative Easing programme to include purchase of housing-issued bonds.

13. Motion submitted in accordance with Council Procedure Rule 14 as to a High Speed Rail Link for the North of England

To consider the following Motion submitted in the names of Councillors Turner, Marchington, A Pinnock, K Pinnock, Iredale, P Scott, Lawson, Burke, Ridgway, Blanchard and Wilkinson.

That This Council:

- (1) After decades of neglect by successive national Government, welcomes, in principle, the proposed creation of a transpennine high speed rail link for the North of England.
- (2) Sees this announcement as an indication that Central Government is finally waking up to the need to invest in northern infrastructure in order to allow northern town and cities to release their true economic potential.
- (3) Believes such a development:
- a) would be a huge boost to Kirklees businesses and would help to better balance the UK economy which is too reliant on the South of England;
- b) would create new jobs and business opportunities in Kirklees improving peoples prospects , health and quality of life;
- c) would increase business rates revenue that could be spent on the provision of local public services in Kirklees.
- (4) However, also believes that what has been described as HS3 and as running between Manchester and Leeds:
- a) should Stretch from Liverpool to Hull connecting towns, cities, ports and airports from East to West across the North of England;
- b) would be of greater value to the UK economy than HS2;
- c) should be delivered as soon as possible, either at the same time or in place of HS2.
- (5) Furthermore, also believes that if northern towns and cities are to go on to truly compete at a national and international level, investment in infrastructure needs to be accompanied by greater devolution of both fiscal and decision making powers to regional and local levels.
- (6) Therefore resolves to instruct the Chief Executive to write to the Leaders of the main political parties at Westminster:
- a) informing them of Council's support for high speed rail in the north;
- b) recommending to them that the high speed rail link runs the whole breadth of the North of England, connecting towns, cities, ports and airports from Liverpool to Hull;
- c) advising them that Council believes that such an investment would be of greater value to the UK economy than HS2 and as such it should be delivered as soon as possible, either alongside or in place of HS2;
- d) urging them to marry investment in infrastructure with greater devolution of fiscal and decision making powers to regional and local authority levels so people living in the north and elsewhere can create the conditions for greater economic growth and the eventual creation of a balanced sustainable economy across all parts of the UK.

Kirklees: Unemployment Rate

From a highpoint of over 8% in 2010–2013, Kirklees has experienced a decline in its unemployment rate, at an average of approximately -0.3 percentage points per year since 2010. If this trend were to continue to 2020, the unemployment rate would return to a similar level to that experienced in 2004 and 2005.




Figure 1: Kirklees unemployment rate 2004–2020

Figure 1 and Table 1 below present the unemployment rate for Kirklees from the historical ONS modelled data (2004–2016), a continued trend of recent years to 2020, and the unemployment rate assumptions applied under the **Jobs-led SENS1** scenario which underpins Kirklees' OAN.
