# 4. Board Matters – Update on Advance Funding - Presented by Peter Thompson, Paper Circulated.

PT – 14<sup>th</sup> August Council on behalf of the Town Board submitted proposal to Ministry of Housing, Communities & Local Gov for the £750k accelerated fund. September 2020 funding approved by MHCLG. Council officers now undertaking work to progress accelerated projects. Key Decision Notice to be taken to Cabinet 18<sup>th</sup> November to allow council to enter into 3<sup>rd</sup> party agreements.

PT – Referenced the Town Fund Accelerated paper that has been circulated to the Town Board to seek approval for flexibility around allocation of funds based on the changes to the Station Gateway proposed project. No objections raised prior or during the meeting by members.

CS – noted help/advice from HE will be given if needed when dealing with any projects that are within the conservation area.
