**KIRKLEES COUNCIL (DENBY DALE 156) DEFINITIVE MAP MODIFICATION ORDER
2024**

This Order is made by Kirklees Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 (“the Act”) because it appears to that authority that the West Yorkshire Metropolitan County Council Definitive Map and Statement for the Kirklees Area require modification in consequence of an event specified in Section 53(3)(c)(i) namely the discovery by the Authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public footpath.

The Authority has consulted with every local authority whose area includes land to which the Order relates. Kirklees Council hereby order that:

1. For the purpose of this Order the relevant date is 19th September 2024.
2. The West Yorkshire Metropolitan County Council Definitive Map and Statement for the Kirklees Area shall be modified as described in Parts I & II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the “Kirklees Council (Denby Dale 156) Definitive Map Modification Order 2024”.

DESCRIPTION OF PATH OR WAY TO BE ADDED

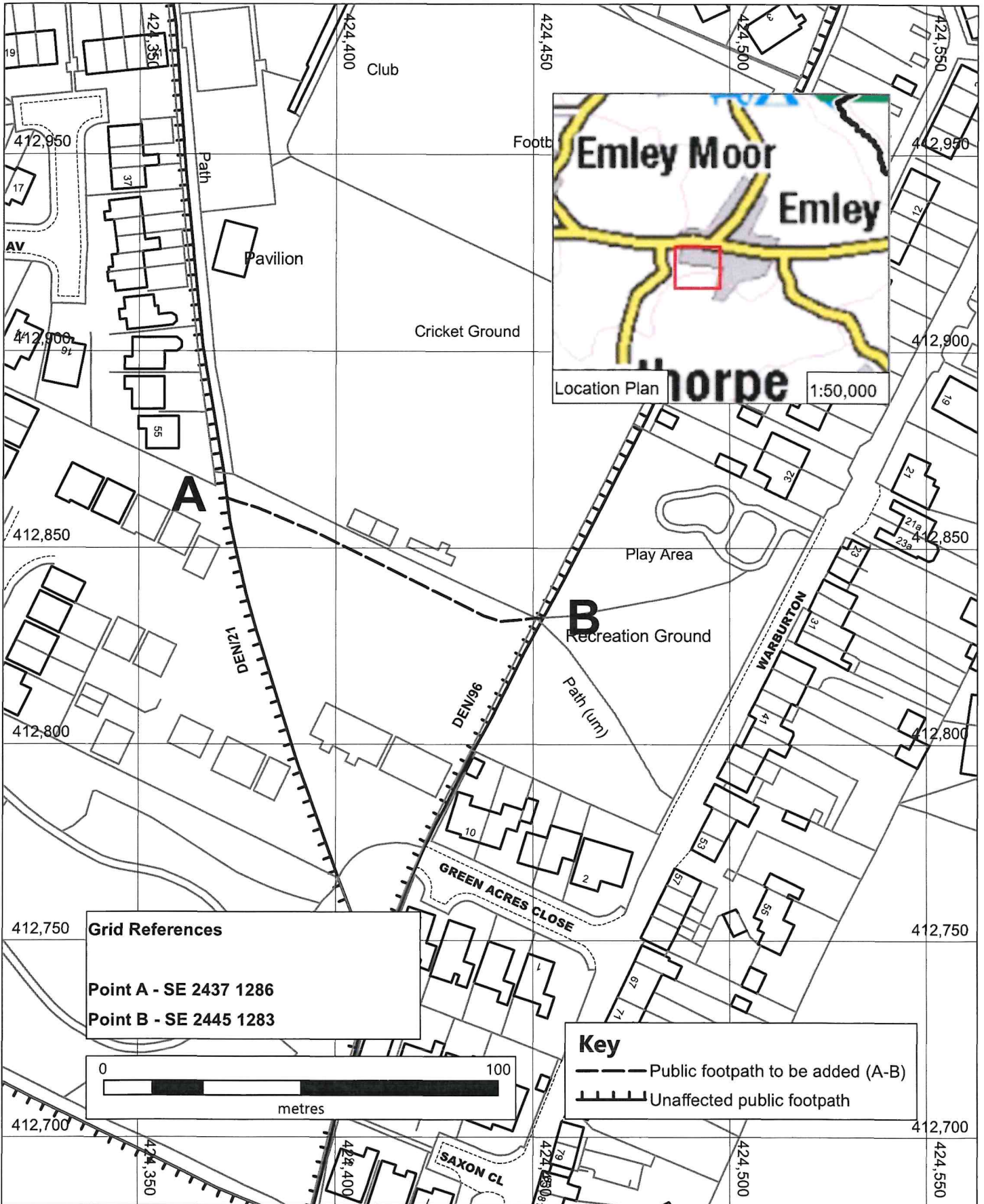
A public footpath 1.2 metres wide as shown on the map annexed hereto by the broken black line with short intervals some 86 metres in length commencing on Denby Dale 21 south-east of No. 55 Wentworth Avenue at grid reference SE 2437 1286 (Point A on the map) and leading south-easterly to join Denby Dale 96 at Warburton Recreation Ground at grid reference SE 2445 1283 (Point B on the map).
