KIRKLEES COUNCIL (HUDDERSFIELD 231 – SANDY LANE TO NETHER MOOR
ROAD, SOUTH CROSLAND) DEFINITIVE MAP MODIFICATION ORDER 2020**

This Order is made by Kirklees Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 (“the Act”) because it appears to that Authority that the West Yorkshire Metropolitan County Council Definitive Map and Statement for the Kirklees Area requires modification in consequence of an event specified in Section 53(3)(c)(ii), namely the discovery by the Authority of evidence which (when considered with all other relevant evidence available to them) shows that a highway shown in the map and statement as a highway of a particular description ought to be there shown as a highway of a different description.

The Authority has consulted with every Local Authority whose area includes land to which this Order relates. The Kirklees Council hereby orders that:-

1. For the purpose of this Order the relevant date is 29 July 2020.
2. The West Yorkshire Metropolitan County Council Definitive Map and Statement for the Kirklees Area shall be modified as described in Part I and Part 2 of the Schedule to this Order and as shown on the map attached hereto.
3. This Order shall take effect on the date it is confirmed and may be cited as the “Kirklees Council (Huddersfield 231 – Sandy Lane to Nether Moor Road, South Crosland) Definitive Map Modification Order 2020”.

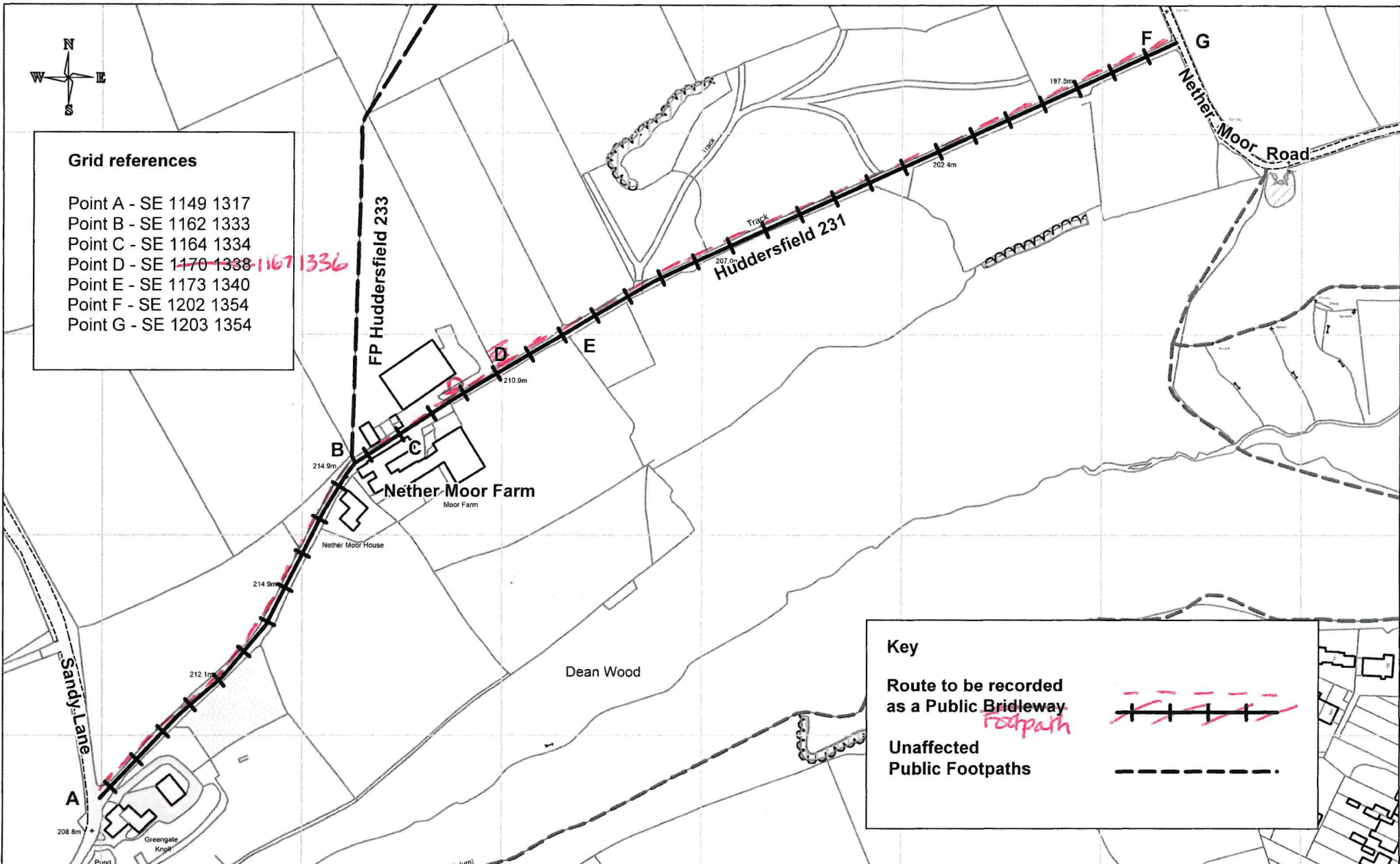
