WEST YORKSHIRE METROPOLITAN COUNTY COUNCIL DEFINITIVE MAP AND STATEMENT FOR THE KIRKLEES AREA

KIRKLEES COUNCIL (MELTHAM 70 AND MELTHAM 38 (PART) – WILSHAW ROAD TO WOOD NOOK LANE, MELTHAM) DEFINITIVE MAP MODIFICATION ORDER 2024

The above Order, made on 28 May 2024, if confirmed as made will modify the definitive map and statement for the area by:

- i) upgrading from a footpath to a bridleway Meltham 70 from Wilshaw Road at grid reference SE 1203 0961 to Meltham 38 at Lower Cote (ruin) at grid reference SE 1189 1057
- ii) upgrading from a footpath to a bridleway part of Meltham 38 from its junction with Meltham 70 at Lower Cote to its current termination point near Wood Nook House at grid reference SE 1208 1065.
- iii) Adding a bridleway from the current termination point of Meltham 38 at grid reference SE 1208 1065 near Wood Nook House to its junction with Wood Nook Lane at SE 1213 1063.

Any representations or objections relating to the Order must be sent or delivered in writing addressed to Harry Garland, Kirklees Council, Legal Services, PO Box 1720, Huddersfield, HD1 9EL not later than 18 July 2024. You should quote reference HG/D105-176 and state the grounds on which your objection/representation is made.

If no representations or objections are duly made to the Order, or if any so made are withdrawn, the Kirklees Council, instead of submitting the Order to the Secretary of State for the Environment, Food and Rural Affairs (or part of it if the authority has by notice to the Secretary of State so elected under paragraph 5 of Schedule 15 to the Wildlife and Countryside Act 1981) may itself confirm the Order (or that part of the Order). If the Order is submitted to the Secretary of State for the Environment Food and Rural Affairs, in whole or in part, any representations or objections which have been duly made and not withdrawn will be sent with it.
