





Privacy Notice (How we use your information) Kirklees Skills Bootcamp - Individuals

Kirklees Council is committed to supporting participants into further education, employment, and training or volunteering. To do this, the Council secures external funding from a number of funding bodies. Employment & Skills receives funding from the West Yorkshire Combined Authority and Department for Education to deliver a programme of Skills Bootcamps targeted at Kirklees residents aged 19+.

Delivery of Skills Bootcamp courses run for up to 16 weeks, 60 Guided Learning hours (non-digital), and up to 100 guided learning hours (digital) and form part of the government's commitment to helping adults learn the necessary knowledge and skills for new jobs in expanding sectors, such as digital, engineering, construction, manufacturing, and green technologies. They are developed by training providers in partnership with employers.

The following organisations deliver Skills Bootcamp provision on behalf of the Council:

- Kirklees Success Centre
- Qualia Academy
- Textile Centre of Excellence
- Kirklees College

The categories of information that we collect, process, hold and share include:

In order to provide you with high quality, safe services that are relevant to your needs, the Council will collect and hold information about you. This will include:

- Personal information (such as name, learner ID/ULN (Unique Learner Number), address, postcode, telephone number, email address, country of residence for last 3 years, National Insurance number, date of birth, qualifications and education level, employment status, length of unemployment/length of employment, hours of employment, earnings and employment information, benefit status, caring responsibilities)
- Special characteristics (such as gender, ethnicity, disability status and type, health information)
- Attendance information
- Achievement information
- Examining Board outcome
- Progression on programme such as completion, volunteering, learning/education & employment
- Eligibility Self Declaration







Why we collect and hold this information:

We use participant data on programmes to:

- Provide you with learning and the most effective support to enable you to develop your learning and skills
- Enable us to carry out specific functions for which we are responsible
- Co-ordinate and deliver services for participants in Kirklees and understand all the potential issues affecting participants
- Target help and support to those who need it most
- Evaluate performance and to set targets for programmes
- Derive anonymised statistics which inform decisions and evaluate the effectiveness of the support provided
- Assess performance and to set targets for programmes.
- Showcase case studies to highlight success stories; this may include sharing with the West Yorkshire Combined Authority, and Department for Education (additional consent will be obtained)

The lawful basis on which we use this information:

We collect and use this information under:-

Article 6: 1(e) processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller;

Article 6: 1(f) It is necessary to collect data from users as the processing is necessary for the organisation's legitimate interests or the legitimate interests of a third party unless there is a good reason to protect the individual's individual data that overrides those legitimate interests

And for the processing of special category data:

Article 9: 2(g) of the GDPR, and Schedule 1, Part 2 paragraph 8 of the Data Protection Act 2018: to ensure equality of opportunity or treatment.

We may request your participation in interviews and surveys as part of the evaluation of the programme. We may request your participation to make checks to ensure that the correct amount of funding is paid. We may also request participation to gather feedback on the Skills Bootcamp.

Storing this information

Kirklees Council holds your personal information in a secure environment. We hold participant data for a minimum of 6 years from the end of the financial year in which the programme ends. Due to funding requirements information will be retained by Kirklees Council as per the contractual requirements with the Department of Education. Currently this is till December 2031. Kirklees Council will retain this information in secure storage as per the retention requirements, after which the records will be destroyed.







Who we share this information with:

We may sometimes share the information we have collected about you where it is necessary, lawful and fair to do so. In each case we will only share the minimum amount of information, only when required, for the following reasons:

- To safeguard vulnerable children, young people and adults;
- To provide and signpost you to other services for additional support or further learning.
- Funding bodies (WYCA & Department of Education)
- Learner Records Service in order to obtain Unique Learner Number (ULN) so any episode of learning may be added to your personal record.
- Delivery Partners.

Any data shared will be transferred, handled, stored and securely destroyed after the completion of the programme in accordance with GDPR.

Why we share this information:

We share participant data with funding bodies as this forms part of our legal requirement. This data sharing underpins funding, educational attainment policy and monitoring and enables them to produce statistics, assess our performance, evaluate government funded programmes, make accurate grant payments and ensure the best use of public funding. We may share your information with local agencies to fulfil our legal requirements under law. We may also share your information with our delivery partners, where you are accessing the programme, in order to ensure that you receive the right level of support.
