NOTES/COMMENTS:

The following comments are made without prejudice and purely from the point of view of the Waste Collection Authority. They are intended to help create an environment that functions safely and efficiently for waste management; Addressing these will also enable the proposal to better meet the policy requirements of LP24 part d (vi), LP43 and the Kirklees Highway Design Guide SPD in respect of refuse collection. Ultimately this will be to the benefit both Lidl and waste contractors for the lifetime of the development.

The applicant has submitted revised plans that relate to relocation/ alteration of orientation/ elevations of the store within the development site.

The internal arrangements within the store e.g. DRS room and Waste storage/ baler that impact on waste storage and collection are unaffected.

As waste is handled/ removed from the site is by reverse logistics, assuming the delivery vehicles can service the site there are not any waste transport issues.
