(TRAFFIC REGULATION) (CONSOLIDATION ORDER PROVIDING ON-STREET PARKING PLACES, WAITING, LOADING AND STOPPING RESTRICTIONS AND MIGRATION TO A 'MAP-BASED' FORMAT) ORDER 2024 (AMENDMENT NO. 17) ORDER 2024

VARIOUS ROADS IN DEWSBURY, CLECKHEATON, LIVERSEEDGE AND BATLEY

The Council of the Borough of Kirklees propose to make the above Order under their powers in the Road Traffic Regulation Act 1984 the effect of which, as it affects lengths of road in the Dewsbury, Cleckheaton, Liversedge and Batley areas of the Kirklees district, will be to:

- (i) Prohibit the waiting of vehicles at any time on lengths of the following roads:-**
 - 1. Bradford Road, Oakenshaw
 - 2. Bradford Road, Cleckheaton
 - 3. Thornton Street, Rawfolds, Cleckheaton
 - 4. Thorntonville, Rawfolds, Cleckheaton
 - 5. Primrose Lane, Rawfolds, Cleckheaton
 - 6. Staincliffe Hall Road, Staincliffe, Batley
 - 7. Northgate, Cleckheaton
 - 8. Dewsbury Road, Cleckheaton
 - 9. Market Street, Cleckheaton
 - 10. Eddercliff Crescent, Littletown, Liversedge
 - 11. Garden Avenue, Littletown, Liversedge
 - 12. Well Street, Littletown, Liversedge
 - 13. Listing Lane, Littletown, Liversedge
 - 14. Ings Road, Littletown, Liversedge
 - 15. Halifax Road, Dewsbury

- (ii) Prohibit the waiting or loading and unloading of vehicles at any time on a length of Bradford Road, Littletown Liversedge**

- (iii) Prohibit the loading and unloading of vehicles at any time on a length of Halifax Road, Dewsbury**

- (iv) Prohibit the waiting of vehicles between the hours of 08:00 – 18:00 (Mondays to Saturdays) on a length of Market Street, Cleckheaton**

- (v) To create disabled parking bays, which will operate on Mondays - Saturdays between the hours of 08:00 -18:00 (with parking limited to a period not exceeding 3 hours with return prohibited within 1 hour) on lengths of the following roads:-**
 - 1. Northgate, Cleckheaton
 - 2. Market Street, Cleckheaton

- (vi) To create free parking spaces, which will operate on Mondays - Saturdays between the hours of 08:00 -18:00 (with parking limited to a period not exceeding 1 hour with return prohibited within 1 hour) on lengths of the following roads:-**

3. Northgate, Cleckheaton
4. Market Street, Cleckheaton

(vii) Modify the existing No Waiting at Any Time restrictions on lengths of the following roads:-

1. Bradford Road, Littletown, Liversedge
2. Primrose Lane, Rawfolds, Cleckheaton
3. Halifax Road, Dewsbury
4. Northgate, Cleckheaton

(viii) Modify the existing goods vehicle loading place on a length of Bradford Road, Littletown, Liversedge

(ix) Modify the existing bus parking place on a length of Bradford Road, Littletown, Liversedge

(x) Modify the existing School Keep Clear restrictions on a length of Staincliffe Hall Road, Staincliffe, Batley

(xi) To revoke certain items in the Kirklees Council (Traffic Regulation) (Consolidation Order Providing On-Street Parking Places, Waiting, Loading and Stopping Restrictions and Migration to a 'Map-Based' Format) Order 2024 which will be redundant when certain parts of the restrictions referred to above are introduced
