(TRAFFIC REGULATION) (CONSOLIDATION ORDER PROVIDING ON-STREET PARKING PLACES, WAITING, LOADING AND STOPPING RESTRICTIONS AND MIGRATION TO A 'MAP-BASED' FORMAT) ORDER 2024 (AMENDMENT NO. 06) ORDER 2025

## BRADFORD ROAD, CLECKHEATON; BRADFORD ROAD, OAKENSHAW; AND HALIFAX ROAD, DEWSBURY

The Council of the Borough of Kirklees propose to make the above Order under their powers in the Road Traffic Regulation Act 1984 the effect of which, as it affects lengths of roads in the Cleckheaton, Oakenshaw and Dewsbury areas of the Kirklees district, will be to:

- 1. Create a mandatory cycle lane over a length of Bradford Road, Cleckheaton (operating at all times)
- 2. Create a Bus Lane (that will allow pedal cycles) over a length of Bradford Road, Oakenshaw (operating at all times)
- 3. Modify the existing Bus Lane that will allow pedal cycles and operate at all times over a length of Halifax Road, Dewsbury

**REASON:** This order is proposed to introduce a number of moving traffic changes along the A638 Dewsbury to Oakenshaw corridor and connected side roads, this work is being funded by a collaborative initiative between Kirklees Council and the West Yorkshire Combined Authority to reduce high traffic volumes along the A638 which contribute to congestion, reduced air quality, and safety concerns for pedestrians and cyclists.

The moving traffic changes are new bus lane on Bradford Road, Oakenshaw, bus lane amended hours of operation on Halifax Road, Dewsbury, mandatory cycle lane Bradford Road, Cleckheaton.

The implementation of these changes is expected to increase road safety for pedestrians and cyclists.
