

**KIRKLEES COUNCIL
(SPEED LIMIT) (NO. 121) ORDER 2024
BRADFORD ROAD, OAKENSHAW
(30MPH SPEED LIMIT AND 40MPH SPEED LIMIT)**

The Council of the Borough of Kirklees ("the Council") in exercise of their powers under Sections 81, 82 (2) and 84 (1) (a) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order which relates to lengths of road in the Oakenshaw area of the Kirklees District.

SPEED LIMITS

1. No person shall drive any motor vehicle at a speed exceeding 30 mph on the lengths of the road specified in the First Schedule
2. No person shall drive any motor vehicle at a speed exceeding 40 mph on the length of the road specified in the Second Schedule

REVOCATIONS

3. The speed limit provisions listed in the Third Schedule shall hereby be revoked to the extent as set out in the Third Schedule

GENERAL

4. Except where the context otherwise requires, any reference in this Order to a numbered Article is a reference to the Article bearing that number in this Order and any reference to a numbered Schedule is a reference to the Schedule bearing that number in this Order.
5. Any reference to a Statute or Statutory Instrument in this Order shall include reference to any subsequent Statute or Statutory Instrument where the context requires it.
6. This Order shall come into effect on the [DAY] day of [MONTH] Two Thousand and Twenty Three and may be cited as the "Kirklees Council (Speed Limit) (No.121) Order 2024".

40mph Speed limit

Name of Road	Length affected
Bradford Road, Oakenshaw	From a point 1098 metres southeast of the junction with the produced southeastern kerbline of Mill Carr Hill Road for a distance of 62 metres in a south easterly direction
