

**KIRKLEES COUNCIL  
(TRAFFIC REGULATION) (CONSOLIDATION ORDER PROVIDING ON-STREET  
PARKING PLACES, WAITING, LOADING AND STOPPING RESTRICTIONS AND  
MIGRATION TO A 'MAP-BASED' FORMAT) ORDER 2024 (AMENDMENT NO. 4) ORDER  
2024**

**WHITEHALL ROAD WEST & BIRCH WOOD ROAD, BIRKENSHAW**

The Council of the Borough of Kirklees propose to make the above Order under their powers in the Road Traffic Regulation Act 1984 the effect of which, as it affects lengths of road in the Birkenshaw area of the Kirklees district, will be to amend the Kirklees Council (Traffic Regulation) (Consolidation Order Providing On-Street Parking Places, Waiting, Loading And Stopping Restrictions and Migration to a 'Map-Based' Format) Order 2024 so as to:

- **Prohibit the waiting at any time on lengths of the following roads:**

1. Whitehall Road West, Birkenshaw
2. Birch Wood Road, Birkenshaw

**REASON:** As part of an approved Planning Application No. 2019 / 90527, a new fourth arm is to be constructed to an existing roundabout for the provision of vehicular access to a residential development on Birch Wood Road. To ensure the unobstructed operation of the A58 Whitehall Road West, and to ensure residents do not park on the A58 and obstruct access and visibility to Whitehall Road West / Birch Wood Road, it is proposed to prohibit parking to the frontage of the development, extending through the roundabout and into the newly created junction. It is believed these proposals will improve road safety for all road users.
