MIGRATION TO A 'MAP-BASED' FORMAT) ORDER 2024 (AMENDMENT NO. 1) ORDER

**VARIOUS ROADS IN HUDDERSFIELD**

The Council of the Borough of Kirklees propose to make the above Order under their powers in the Road Traffic Regulation Act 1984 the effect of which, as it affects lengths of road in the Huddersfield area of the Kirklees district, will be to:

- (i) **Prohibit the waiting of vehicles at any time on lengths of the following roads:-**
1. Quay Street, Huddersfield
  2. St Helen's Gate, Huddersfield
  3. Newsome Road South, Huddersfield
  4. Plantation Drive, Huddersfield
- (ii) **Prohibit the waiting of vehicles between the hours of 10:00 – 14:00 (Mondays – Fridays) on a length of Newsome Road South, Huddersfield**
- (iii) **Prohibit the waiting or loading and unloading of vehicles at any time on a length of Queen Street, Huddersfield**
- (iv) **To create a loading bay which will operate at all times (with waiting limited to a period of 30 minutes) on Quay Street, Huddersfield on its South Side**
- (v) **Modify the existing School Keep Clear restrictions on St Helen's Gate, Huddersfield**
- (vi) **Modify the existing No Waiting at Any Time restrictions on Arkenley Lane, Huddersfield**

AND

- (vii) **Revoke items in the Kirklees Council (Traffic Regulation) (Consolidation Order Providing On-Street Parking Places, Waiting, Loading and Stopping Restrictions and Migration to a 'Map-Based' Format) Order 2024, which will be redundant when certain parts of the restrictions referred to above are introduced.**
